



2018 Andy Hyman Award FOR ADVOCACY

Background

The field of health philanthropy lost one of its greatest champions when Andy Hyman of the Robert Wood Johnson Foundation passed away in 2015.

Andy was an avid supporter of Grantmakers In Health (GIH). He was the driving force behind several of GIH's most lauded health reform activities, including the State Grantwriting Assistance Fund, the Federal-State Implementation Program, and the Outreach and Enrollment Learning Community.

As a Team Director and Senior Program Officer at Robert Wood Johnson Foundation (RWJF), Andy focused on the foundation's efforts to expand coverage and secure meaningful access to health care for all Americans. He recognized that “the promise of equal opportunity in this country is empty while we permit millions to be uninsured.” Having joined the foundation in 2006, he worked with policy and communications experts, researchers, and advocates to help state and national policymakers enact and implement policies designed to expand coverage. In addition, Andy worked with the foundation's staff to develop strategy and design programs to address violence and its impact on children and families, with a particular focus on mental health.

In the decades prior to his work at RWJF, Andy served as Director of Government Relations and Legislative Counsel for the National Association of State Mental Health Program Directors, Deputy Director and then Director of the Office of Intergovernmental Affairs at the U.S. Department of Health and Human Services (HHS), and Special Assistant to the General Counsel at HHS.

The Award

First presented by Grantmakers In Health in 2017, the Andy Hyman Award for Advocacy recognizes a nonprofit or public sector champion who:

- Exhibits persistence, courage, and determination in the field of health advocacy.
- Embodies Andy's commitment to principled action and passionate leadership that advances social change.
- Demonstrates a dedication to making progress in policy and practice despite challenging political environments.
- Inspires philanthropy to support grantees who fight for social justice and meaningful access to health care for all Americans.
- Advances a strategic vision that is focused on achieving effective results with a broad impact.
- Embraces an attitude of optimism, good humor, and humility in their work.

The award carries a \$5,000 honorarium. This award is made possible through the support of the Robert Wood Johnson Foundation.

Eligibility

Only GIH Funding Partners may nominate current or former grantees for this award using the nomination process described below. The nominee must be an individual; organizations cannot be nominated for the award. Funding Partners can nominate grantees for their work in the nonprofit or public sectors. Foundation staff and trustees are not eligible to be nominated for this award. Awardees can be at any stage in their career and at any position within their organization. The recipient must be available to participate in the luncheon award presentation, which will be held during the 2018 GIH Annual Conference on Health Philanthropy, from June 20-22 in Chicago, Illinois.

The Nomination Process

A complete nomination of an eligible candidate consists of the following:

- A background profile of the nominee, including a summary of how the nominee meets the criteria for this award (see Award Criteria). This summary may take the form of a letter that addresses the nominee's achievements and relevant qualities. The letter should not exceed five single-spaced, typed pages. The extent to which the letter makes a succinct case for the candidate is more important than the letter's length.
- Indications of support from two individuals who are willing to be contacted by the selection committee, if necessary. One of these individuals must be from an entity other than the nominator's foundation.



- Complete contact information, including name, title, organization, address, telephone number, and email address for the nominee, nominator, and the two persons who second the nomination. A form for submitting this information is attached. Members of the award committee may contact the persons listed for additional information about a candidate.
- No more than three attachments that illustrate the nominee’s achievements, which may include items authored by the nominee, materials produced under the nominee’s leadership, and media articles about the nominee or their work.

Nominations must be received by Friday, December 1, 2017.

Award Criteria

Nominators are encouraged to address the following questions in their submission:

- Describe the nominee’s achievements and how they have fought for social justice and improved health for all Americans. How has this individual challenged the status quo? In what ways have they demonstrated courage and persistence in their work?
- Describe the nominee’s commitment to principled action and passionate leadership. How has this individual demonstrated these qualities within their own organization or community? How have they shown these qualities within the broader field of health advocacy?
- How has the nominee worked effectively across policy sectors and made connections that make a meaningful difference in overcoming resistance in politically polarized situations? Describe this individual’s willingness and ability to ‘pick the right fight’ by balancing their passion with a practical approach.
- Some grantees help foundations to do their work differently. They encourage funding for a cause and they understand how foundations can influence the course of an issue. Describe how this nominee has inspired philanthropy.
- How has the nominee advanced a compelling strategic vision for their advocacy work, the persistence to carry it out, and the ability to bring others along with them? What distinguishes this nominee’s commitment to achieving results and measurable outcomes?
- Describe how the nominee’s personality has contributed to their success. How has this individual embraced optimism, good humor, and humility in their work?

The Selection Process

The recipient of the award is selected by a committee chosen by GIH, which will include current and former grantmakers from GIH Funding Partner organizations. A member of the GIH board of directors chairs the committee but does not have a vote. The committee will review all nominations and choose a single awardee. The decisions of the selection committee are final and not subject to review by the GIH board, staff, or its Funding Partners. The award recipient and nominators will be notified of the committee’s decision in March 2018.

The award will be presented during the 2018 GIH Annual Conference in Chicago, Illinois.
