Fighting off ACA Repeal

- Repeal would have devastated SUD/MH coverage
 - Ending coverage for single adults
 - Returning to discriminatory or skimpy policies
 - Disproportionately harming people of color
 - Setting back alternatives to incarceration
- Intersectional coalitions mobilized in support of ACA; SUD critical issue
- Broader public support for ACA and Medicaid
- Full repeal seems unlikely but ...





Continuing Threats from Trump Administration

- Reducing insurance subsidies
- Slowing enrollment
- Squeezing Medicaid through bad waivers
- Weakening Essential Health Benefits





Possible Upcoming Congressional Action

- ACA "fixes" proposed
 - Hearings on stabilizing private insurance
 - Graham-Cassidy block grant proposal
 - Problem Solver Caucus
- Vehicles for possible Medicaid cuts
 - Budgets and appropriations
 - Tax cuts
 - CHIP reauthorization
 - Lifting debt ceiling





Federal Decisions on Access to Addiction Care

- The administration
 - Work to examine and address the opioid crisis
 - White House Opioid Commission's interim recommendations and potential next steps
 - Decision-making at CMS
 - Work at the Department of Justice





Federal Decisions on Access to Addiction Care (cont'd)

- Congress
 - The FY 2018 appropriations and FY 2019 budget process
 - Safety net funding through SAMHSA; new monies through 21st Century CURES and CARA
 - Legislation related to the opioid crisis





Federal Defense and Offense: What's Needed

- Reinforce value of ACA and Medicaid
- Use interest in opioid crisis to advance broader SUD/MH agenda, including parity and diversion
- Expand advocacy capacity, stakeholder engagement, public education
- Support state advocacy for innovation and to fill gaps





Federal Defense and Offense: What's Needed

- Continued need to emphasize a public health, not punitive response, to addiction
- Broadening and deepening our base of support
- Using data to more specifically identify needs and opportunities
- Supporting alliances at the local level between advocates who work to promote health and justice





State/Local Opportunities: Building on Gains

- Leveraging the requirements of the ACA and the Mental Health Parity and Addiction Equity Act to improve access to care
 - Coverage of the full continuum of SUD care in all public and private insurance
 - Ensuring meaningful access by eliminating discriminatory restrictions to care
- Improving care access to people involved in the criminal justice system
 - Developing systems that promote seamless coverage and access to care





More State and Local Opportunities

- Health system transformation through managed care, ACOs, waivers
 - increase access
 - address social determinants
 - integrate BH, strengthen quality
- Community alternatives to incarceration, particularly pre-arrest
- Prevention in clinics and in schools
- Strengthen parity





State Defense and Offense: What's Needed

Many policy avenues to pursue but all rely on strong public education and multidisciplinary advocacy

- Strengthen the voices for progress
- Support broad coalitions and boost policy and strategy expertise
- Help state and local groups connect with leading national organizations working at the ground level
