# NEW GRANTS & PROGRAMS

Austin Bailey Health and Wellness Foundation (Canton, OH) approved grant requests totaling \$173,950 to 14 nonprofit organizations located in Ohio's four-county area that encompasses Holmes, Stark, Tuscarawas, and Wayne counties. Among the grantees are: Wayne Holmes Mental Health Coalition (Wooster) - \$15,000 to maintain its services for adults with severe and persistent mental health concerns; Western Stark Free Clinic (Massillon) -\$10,000 to support free medical and dental care to qualified recipients; **Tuscarawas County Child Advocacy** (New Philadelphia) - \$8,500 for intervention services for children who are victims of abuse; and YMCA of Western Stark County (Massillon) - \$5,000 to provide membership funds to enroll persons who are unable to afford it. In addition to the above grants, the foundation provided \$4,000 scholarships to students at Aultman College (Canton); Kent State University, Stark (North Canton); Kent State University, Tuscarawas (New Philadelphia); Malone University (Canton); Stark State College (North Canton); University of Mount Union (Alliance); and Walsh University (North Canton). Recipients of these scholarships are all engaged in health-related studies. #### The California Endowment

(Los Angeles) announced a \$90 million, multiyear plan to increase the capacity of the state's existing health care delivery system to accommodate newly enrolled Californians under the Affordable Care Act. The investment is part of the Health Happens Here campaign and 10-year plan for **Building Healthy** Communities by improving employment opportunities, education, housing, neighborhood safety, unhealthy environmental conditions, access to healthy food, and more. Among the projected investments are: \$31 million for student scholarships and loan repayment programs for health professionals to practice in medically underserved areas; \$21 million for health professional training slots to increase the number of medical professionals trained for medically underserved areas; \$15 million to strengthen K-12/K-16 pathway-pipeline programs that increase career opportunities for young people to pursue jobs in the health field with a regional focus that emphasizes a diverse and culturally

The satellite center will provide primary and preventative health care, chronic disease management, care coordination, and assistance with enrolling in health insurance. Initially there will be two physicians and one nurse practitioner or physician assistant working with a team of nurses, medical assistants, a community health worker, and interpreters to provide comprehensive care to patients. The Leona M. and Harry B. Helmsley Charitable Trust (New York, NY) approved more than \$6.5 million in grants to seven organizations seeking to develop new technologies that will improve the management and ease the burden of people living with type 1 diabetes (T1D). The grants have been made through the trust's Type 1 Diabetes Program as part of its **Emerging Technology Initiative** (ETI). The goal of the ETI is to fund earlier stage projects focused on drugs, devices, or therapies that will ease the burden of managing T1D and move them down the path toward commercialization. Robert Wood Johnson Foundation (RWJF) (Princeton, NJ) and the **Campaign for Tobacco-Free Kids** (Washington, DC) announced a collaborative effort to augment progress toward reducing tobacco use. As part of the three-year initiative, the foundation made an \$8 million grant to the Campaign for Tobacco-Free Kids to support an advocacy initiative aimed at changing local, state, and federal policies focused on preventing children from smoking, smoking cessation efforts, and protection from secondhand smoke.  Geiger Gibson/RCHN Community Health Foundation Research Collaborative (New York, NY) at The George Washington University School of Public Health and Health Services (Washington, DC) issued a report that examines the potential impact of sequestration on community health centers and their patients and communities. Assessing the Potential Impact of Sequestration on Community Health Centers, Patients, and Medically Underserved

Communities estimates that the nation's 1,200 federally funded health centers will lose \$120 million in grant funding, which can be expected to translate into 900,000 fewer patients served and 3 million fewer visits. The analysis shows that the cuts will disproportionately impact the poorest Americans, children, young families, and members of ethnic and racial minority groups, as well as individuals with serious and chronic health care needs. Among the patients losing access to health center services, 72 percent will have family incomes below the federal poverty level; virtually all will have family incomes below twice the federal poverty level; 57 percent will be members of racial/ethnic minority
