## NEW GRANTS & PROGRAMS

- **The Blue Foundation for a Healthy Florida, Inc.** (Jacksonville) announced grants to 11 Florida nonprofits as part of its biannual **IMPACT Health Care** (Improving Access to Health Care) grants program. Among the grantees are: **Shepherd's Hope** (Orlando) – \$100,000 for a care coordinator to organize a network of volunteers that provides specialty medical care for uninsured residents of Seminole County; **Bridgeway Center** (Fort Walton Beach) – \$77,569 to support primary medical care for people involved with the center's mental health program in Okaloosa County; **Caridad Center** (Boynton Beach) – \$75,000 for electronic health record enhancement equipment for uninsured residents of Palm Beach County; **Haitian American Association Against Cancer** (Miami) – \$50,000 to provide breast and cervical cancer education and screenings for Haitian women living in Miami-Dade County; and **Barnabas Center** (Fernandina Beach) – \$40,797 for dental equipment and to support increased access to a dental clinic in Nassau County. commit \$10 billion over 10 years for the research, development, and delivery of vaccines to the world's poorest countries. Current funding adds to the \$4.5 billion that the foundation has already committed to such efforts since its inception. The foundation used a model developed by a consortium led by the Institute of International Programs at the Johns Hopkins Bloomberg School of Public Health to project the potential impact of vaccines on childhood deaths over the next 10 years. By significantly scaling up the delivery of life-saving vaccines in developing countries to 90 percent coverage – including new vaccines to prevent severe diarrhea and pneumonia – the model suggests that between 2010 and 2019 the deaths of 7.6 million children under five years old could be prevented. The Oral Health Foundation was formed in January 2000 by Dental Services of Massachusetts (Delta Dental of Massachusetts) to improve the oral health status of uninsured, high-risk, vulnerable individuals in Massachusetts. From 2000 to 2008, the foundation's grantmaking grew from \$450,000 to \$4 million annually, with the foundation providing more than \$17 million in grants to enhance access, promote prevention, increase public awareness, and replicate effective programs. In 2009 the foundation was renamed DentaQuest Foundation and expanded its programs to a national focus.

**Program Information:** DentaQuest Foundation's grantmaking is focused on three priorities of the United States Surgeon General's Call to Action (2003): to change perceptions about oral health and disease, to overcome barriers by replicating effective programs and proven efforts, and to increase public-private collaborations to improve the oral health of those who suffer disproportionately from oral diseases. These include elders; poor children and families; traditionally underrepresented racial, ethnic, and linguistic populations; newcomers to the United States; residents of rural areas; and people with special health care needs.

The foundation's work has evolved in response to its growing expertise, the changing context for oral health across the nation, and emerging practices in philanthropy. Grantmaking started with small grants that focused on the needs of a specific target population and subsequently moved to multiyear grants for projects with different goals (planning, implementation, clinical equipment replacement, and community-based prevention). With growing acceptance of the role of philanthropy in policy and advocacy, funding progressed to include investments that promote positive policy change in support of better oral health. Today the foundation supports systemic solutions, encouraging public-private funding partnerships that expand the oral health safety net, increase public and legislative awareness of the importance of oral health, and engage nontraditional players to include oral health in their work.


- **University of Maryland (UMD) and Maryland Dental Action Coalition (MDAC)** – Funding to UMD supports a statewide oral health literacy and awareness campaign geared toward low-income and minority populations in Maryland. Funding to MDAC supports development of a statewide coalition. (\$538,229 for one year).

- **The Pew Charitable Trusts** – Baseline information is critical to making the case for change. This grant supports a 50-state assessment of the state of children's oral health in America to acquire baseline data and to highlight public policy initiatives that are making a difference (\$160,000 for one year).
- **Miami-Dade County, Florida, Healthy Smiles in Our Schools, and Health Choice Network, Inc.** – Replicating effective programs, such as school-based oral health services, and strengthening the oral health safety net are proven strategies to improve the oral health of Medicaid-eligible children. Healthy Smiles in Our Schools brings school-based oral health services to 17 schools in Miami-Dade County. Health Choice Network is developing a curriculum for school nurses to deliver oral health education as part of the program (\$107,378 for one year).
- **Massachusetts League of Community Health Centers** – To encourage broader use of dental services, this grant supports improvements to the oral health infrastructure in community health centers across Massachusetts to ensure adequate staffing, best practices in financial management, quality and efficient care, and technical assistance strategies for information systems and technology (\$210,000 for one year).
- **Society of Teachers of Family Medicine (STFM)** – This program supports expansion of STFM's Smiles for Life curriculum to a state-of-the-art multimedia, Web-based oral health learning laboratory, and promotes adoption of the curriculum by medical education centers throughout the nation to prepare medical providers to incorporate oral health into their practice (\$149,000 for one year).

### Challenge for the Future:

income neighborhood in Wichita will have access to a variety of programs aimed at healthful eating and physical activity with the support of a \$55,000 grant to the **Urban League of Kansas** (Wichita). A grant of \$69,800 will support **GraceMed Health Clinic** (Wichita) in assisting eligible low-income Wichita area families with enrollment in **HealthWave** insurance coverage. The **E.C. Tyree Health & Dental Clinic** (Wichita) has been awarded \$12,000 to expand its dental services. With the grant, the clinic will increase its hours to include three evenings a week and Saturday mornings. Services are available on a sliding fee scale based on income. - **Virginia Health Care Foundation** (Richmond) awarded grants totaling more than \$1 million to 14 health safety net organizations across Virginia. **Shenandoah County Free Clinic** (Woodstock) will use funding to hire a full-time dentist to provide dental care to area children and uninsured adults. **Catholic Charities of Eastern Virginia** (Virginia Beach) will apply its grant toward hiring two counselors for its **Access to Therapy** initiative, a mental health program providing mental health counseling to low-income, uninsured adults. Funding to the **Gloucester-Mathews Free Clinic** (Hayes) will allow the organization to substantially increase its pharmacists' working hours, enabling the clinic to fill an additional 24,000 prescriptions annually. - **Lucile Packard Foundation for Children's Health** (Palo Alto, CA) released the results of a study projecting that in 2010, one in four California children may live below the federal poverty level. Despite research indicating that California's families need to earn an income that is at least twice the federal poverty level to cover basic expenses, the projections suggest that as many as 2.7 million California children may live in households where earnings are less than \$22,000 per year for a family of four, an increase of about 850,000 children since 2008. The study also includes projections of poverty for Los Angeles and the Bay Area. The study was conducted by Duke University; findings are available
