# NEW GRANTS & PROGRAMS

- Aetna Foundation (Harford, CT) awarded a \$331,000 grant to Engelberg Center for Health Reform at the Brookings Institution (Washington, DC) to help the center explore innovative approaches to implementing and evaluating value-based purchasing programs to improve the value of health care for health care purchasers. The project will convene a group of experts who will recommend strategic approaches. The project goal is to develop an implementation approach that will improve quality and reduce costs systemwide through the close collaboration of public- and private-sector stakeholders. - Archstone Foundation (Long Beach, CA) announced intended funding for its Spiritual Care Demonstration Projects. The goal of these projects is to advance knowledge, develop leadership, identify and test practices to improve the quality of screening and assessing spiritual needs by the palliative care service, and provide quality spiritual care services to patients and families. This funding opportunity builds on the foundation's work started in 2009 that resulted in a National Consensus Conference, which identified recommendations for improving spiritual care. Recommendations from the conference were published in a special report that appeared in the *Journal of* Palliative Medicine. The foundation will fund up to 10 demonstration projects in southern California to implement

- Blue Cross Blue Shield of Michigan Foundation (Lansing) awarded a \$10,000 grant to Michigan State University (East Lansing) to study the role that statins play in causing disabling tendon ruptures. Statins are commonly prescribed for individuals with high cholesterol. Although statins are effective in lowering cholesterol, studies show that they also inhibit proteins that are necessary to remodel tendons, making them more prone to injury and ruptures. Funding was awarded through the foundation's Physician Investigator Initiated Research Award Program, which provides seed money to investigate important issues related to the health and medical care of Michigan residents. - Connecticut Health Foundation (CT Health) (New Britain); Universal Health Care Foundation of Connecticut (Meriden); Jessie B. Cox Charitable Trust (Boston, MA); and **Robert Wood Johnson Foundation's** (RWJF) (Princeton, NJ) State Coverage Initiatives have collectively awarded \$615,000 to support the successful implementation of SustiNet, Connecticut's health care reform legislation. # DentaQuest Foundation (Boston, MA) awarded \$543,315 in grants to support various oral health projects. University of Maryland Dental School (Baltimore) received a grant for \$219,626 to develop and implement a dental case management pilot in a targeted area of Baltimore, Maryland. The pilot seeks to increase the number of children receiving care; increase the number of children with a dental home; reduce the number of no-show appointments; strengthen patient and provider perception of the importance of oral health to overall health; increase the number of dentists participating in the Maryland Medicaid program; and heighten the awareness of dental issues among case managers. A total of \$218,808 was awarded to Nova

Southeastern University (Ft. Lauderdale, FL) to develop the Training in Special Care Dentistry Program, which will focus on educating case managers on the importance of oral health status to systemic health and provide advanced education opportunities for practicing dentists to provide oral health services for persons with special health care needs who are medically, mentally, or physically compromised. **Endowment for Health** (Concord, NH) awarded more than \$87,000 in grants to various organizations for the resources necessary to forward healthrelated projects that reduce economic, geographic, and social-cultural barriers to health access, and provided support to a variety of health-related nonprofits and policy organizations. Among the grantees are: Upper Connecticut Valley Hospital (Colebrook, NH) -\$20,000 to support the Coos County Hospital Collaborative, which will focus on sustaining the region's health care system by exploring multiprovider partnerships; Health Strategies of New Hampshire (Concord) – \$10,000 for a project that examines alternative policies for financing uncompensated health

### care; Lamprey Health Care

(Newmarket, NH) – \$4,785 for a conference aimed at raising awareness and improving health behaviors to prevent chronic disease among minority populations; and **Elliot Hospital** (Manchester, NH) – \$4,905 to identify best practices to treat postpartum depression. #### Greater Rochester Health

Foundation (NY) awarded four grants totaling \$3 million. The foundation awarded \$2.2 million to four local organizations to help more than 23,000 greater Rochester residents manage hypertension. The grantees are: Rochester General Health System, Unity Health Care System, Culver Medical Group, and Anthony L. Jordan Health Center. In addition, Highland Family Medicine and Lifespan were approved for more than \$1 million in funding over a three-year period for activities to address depression. The two projects combined will screen 17,500 people for depression and treat more than 1,700 people using two different models of care. Friends of the Public Market, a not-for-profit volunteer organization, received a grant of \$100,000 to develop a marketing plan to increase sales of fresh produce to families receiving food stamps. Families may exchange their food stamps for tokens to purchase healthy food at the Rochester Public Market through an electronic transfer system. Health Care Foundation of Greater Kansas City (HCF) (MO) awarded 27 Healthy Lifestyles grants totaling more than \$3.25 million. The City of Kansas City (MO) will use a \$244,525 grant to support the Missouri Public Works Department's efforts to provide leadership to and coordinate project activities with the City Planning, Health, and Youth Advocacy departments and Hickman Mills School District to facilitate policy and behavior change addressing the lack of infrastructure and programs that support a vibrant, active, healthy environment for residents. El Centro received \$121,580 to expand the Health Promotores Program, which

works with Latinos to participate in weight management programs. A \$200,000 grant to Harvesters – The Community Food Network will support its nutrition education and healthy eating programs, Project Strength and Kids in the Kitchen/Kids Café. Funding will also support a new pilot program called Teen Eats. These programs include hands-on cooking lessons, healthy recipes, information about nutrition and nutritious food, as well as teen-focused "hot topics" like body image. Florida (Miami) approved more than \$1.1 million in grants for local programs focused on increasing access to quality primary health care, healthy lifestyles promotion, preventive health measures, oral health, and other community health needs. ## Healthcare Georgia Foundation

- The Commonwealth Fund (New York, NY) released Rite of Passage: Young Adults and the Affordable Care Act of 2010, which describes provisions in recent health care reform that will help cover uninsured young adults, who represent one of the largest segments of the uninsured. The report cites young adults aging off of parents coverage upon graduation from high school or college and losing eligibility for public programs upon turning 19 as major contributors to being uninsured. Some of the pertinent provisions outlined in the issue brief include the ability for young adults to enroll in a parent's health plan up to age 26 beginning in September 2010; significant expansion in eligibility for Medicaid beginning in 2014; and the creation of state or regional health insurance exchanges with subsidized private insurance for people with low and moderate incomes, also beginning in 2014. - Missouri Foundation for Health (St. Louis) announced the release of a new brochure that provides plainlanguage explanations of key of health care reform provisions. Frequently Asked Questions About Federal Health Care Reform examines the new law's impact on Missouri families and businesses, and includes a timeline showing

when key provisions of the law are expected to take effect. The brochure can be used as an educational tool for the public, care providers, legislators, media representatives, faith-based organizations, and others involved in writing and speaking about reform.
