NEW GRANTS & PROGRAMS

- **Archstone Foundation** (Long Beach, CA) announced nearly \$2 million in grants to 16 California-based organizations that support the needs of the state's aging population. Among the grantees are: **Brentwood Biomedical Research Institute** (Los Angeles) – \$200,000 to support **Incorporating Spiritual Care into Palliative Care**, which seeks to improve spiritual care for veterans with advanced illness at the Veterans Administration Greater Los Angeles Healthcare System; **Cedars-Sinai Medical Center** (Los Angeles) – \$200,000 to maximize contributions of the chaplaincy and palliative care teams and enhance the spiritual care and well-being of palliative care patients and their families; **California Dental Association Foundation** (Sacramento) – \$51,425 for its **Senior Oral Health Training in Long-Term Care Facilities** project, which will train dental hygienists who will train and mentor staff at nursing homes in Los Angeles County; and **Alzheimer's Family Services Center** (Huntington Beach) – \$10,000 to support the **JumpStart Program**, which seeks to empower individuals who are experiencing early memory loss. The 34-foot mobile office is fully equipped with an exam room; two private offices for social work, medical interviews, or other services; storage space; and Wi-fi capability for electronic medical records accessibility. Unity has been providing services to District residents for more than 25 years. The new vehicle will provide a full range of services such as primary medical care, substance abuse assessments and prevention education, HIV/AIDS rapid testing and counseling, glucose screening, referrals to specialty care, and linkages into one of Unity's medical homes for ongoing medical services. The Edna McConnell Clark Foundation (New York, NY) announced a new funding opportunity as an intermediary grantmaker for the Social Innovation Fund (SIF). The foundation will grant \$10 million in SIF funds and \$10 million in matching funds from their endowment to 8 to 10 high-performing, youth-serving nonprofits in 2011. These grants, which will generally be multiyear and for a minimum of \$2 million annually, will provide upfront growth capital to help recipients build their evidence base and organizational capacity to prepare for greater public and private investment that can propel them to scale and sustainability. The foundation's goal is to expand the pool of organizations with proven programs that can help low-income young people – especially those at greatest risk of failing or dropping out of school, of not finding work, and/or of becoming involved in the foster care or juvenile justice system –

- **The Colorado Trust** (Denver, CO) awarded \$250,000 in honor of its 25th anniversary. Ten organizations will receive a \$25,000 grant to continue their collaborative efforts to ensure the provision of health coverage and care to children. Among the grantees are: **Bright Futures for Early Childhood** (Telluride), which works together with local health care providers in four counties, school based-health systems, and other entities to coordinate and provide primary, mental, and dental health care to children, and to increase immunizations and health insurance enrollment; **Colorado Medical Home Initiative** (Denver), which brings together agencies, families, hospitals, organizations, and policymakers that collectively strive to ensure that Colorado children receive comprehensive coordinated health care services within a medical home; and **Family Medicine Center** (Ft. Collins), which partners with local obstetricians and a local hospital to provide prenatal care to low-income or uninsured patients, prescription assistance, behavioral and mental health services, and other services. - **Connecticut Health Foundation** (New Britain) announced a six-year, \$5.4 million commitment to continue addressing the oral health needs of the state's most vulnerable populations. This new initiative will focus on prevention and treatment that include pregnant women and their children from birth to age five. It seeks to improve the oral health of children from low-income families by supporting the incorporation of oral health at every point where children and their families intersect with health care, human service, and education systems. This year's investment will fund selected organizations researching factors that affect the uptake of oral health care among low-income pregnant women, identifying the most promising oral health promotion strategies and programs, and developing and implementing systems of care to incorporate the new learning into oral health promotion strategies. A second edition, released in July 2008, added modules on fluoride varnish and oral health in pregnancy; its focus was expanded to include all primary care clinicians, including physicians, physician assistants, and nurse practitioners. The current edition continues the broad focus on all primary care clinicians, while adding opportunities for individual learners through interactive on-line learning. The facility will house 32 clients needing rehabilitation, residential treatment, education, and advocacy services for their chronic substance abuse. The foundation also authorized a \$500,000 grant to **Sunshine Community Health Center** over two years for the construction of a new permanent primary care clinic in Willow. This satellite center will offer

comprehensive patient care, including mental health, dental care, and digital radiology services, to Willow's growing population, and provide access to health care for the uninsured and underinsured via a sliding fee scale. Among the grantees are: **United Cerebral Palsy Association of Greater Chicago** (IL) – \$366,912 to benefit 16,000 children in Georgia and 9,500 children in Minnesota by providing teaching resources for children with specialized learning needs; **IVUmed** (Salt Lake City, UT) – \$100,000 to make quality urological care available to people worldwide by providing medical and surgical training; and **Women's Equity in Access to Care and Treatment (WE-ACTx)** (Rwanda) – \$253,600 for a pediatric and youth program that serves 600 children suffering from HIV/AIDS. - **United Methodist Health Ministry Fund** (Hutchison, KS) and **Robert Wood Johnson Foundation** (Princeton, NJ) introduced a new initiative to help promote mental health and to prevent or minimize the impacts of social and emotional issues on a child's development. The pilot program is aimed at encouraging coordinated early identification and early intervention for the mental health of young children in Kansas communities. In the initial pilot phase, funders anticipate supporting two to three programs with a total investment of \$600,000. The selected grantees will have a strong evaluation component and will represent specific stakeholders that include mental health centers or mental health providers, early childhood education, primary medical care providers, faith communities, government, and consumers. SURVEYS, STUDIES & PUBLICATIONS

- **California HealthCare Foundation** (Oakland) has released *California's Health Care Safety Net: Facts and Figures*, a **California HealthCare Almanac** report that provides a snapshot of how implementation of federal health reform will produce fundamental transformation and reshaping of the health care safety net, dramatically expanding both Medicaid and private insurance coverage. A key assertion in the report is that in general, the safety net patient population receives less in the way of health care services than the non-safety net population (those who are insured or have incomes above 300 percent of the federal poverty level). Similarly, the safety net population is more likely to lack a usual source of care, delay needed care, and be hospitalized for an avoidable cause. Further, the report notes that the largest safety net providers are public hospitals and private nonprofit hospitals, which together provide 70 percent of inpatient and 82 percent of outpatient hospital care under Medi-Cal. - **The Commonwealth Fund's** (New York, NY) new report *Health Insurance Exchanges and the Affordable Care Act: Eight Difficult Issues* explores the design and implementation of health insurance exchanges, which are a key element of the Affordable Care Act. The state-based exchanges will play a major role in enhancing Americans' access to health insurance coverage when they are fully implemented in 2014. The report examines issues that policymakers will confront as they work to implement the exchanges and provides detailed recommendations to improve affordability and access to coverage purchased through the exchanges. These include how exchanges should be set up and governed, how they can avoid adverse selection, and how to reduce administrative costs. The fund will also host a Webinar on November 4, 2010, that will address health insurance exchanges. The event will feature the report's author **Timothy Stoltzfus Jost**, professor of law at the Washington and Lee University School of Law, and other experts in the field. - **The Nathan Cummings Foundation** (New York, NY), **Robert Wood Johnson Foundation** (Princeton, NJ), **Josiah Macy, Jr. Foundation** (New York, NY), and other supporters have funded the making of *FIRESTORM*, a video production that addresses the role of firefighters as vital components to the health care safety net, as ambulances are increasingly turned away from emergency rooms because of overcrowding. The film's producer and director, **Julie Winokur**, captures the activities of Los Angeles Fire Department (LAFD) Station 65, located in South Los Angeles' Watts community, a neighborhood with a largely uninsured and undereducated population. The LAFD handles all emergency medical services for the city of Los Angeles where currently 82 percent of the department's work is medical rather than fire-related. - **Maine Health Access Foundation** (MeHAF) (Augusta) funded the production of *Maine Children's Mental Health: 2010*, a new report that provides a broad overview of children's mental health in Maine. The report is part of MeHAF's **Integration Initiative**. The document highlights the importance of early childhood screening for mental and behavioral health issues prior to children beginning kindergarten, and other key data and recommendations. The report recognizes the advantages of integrating mental and behavioral health services with broader health and social services, and linking data systems to track the progress of children as they mature. - **Missouri Foundation for Health** (St. Louis) has released the findings of a recent telephone survey measuring Missourians' attitudes toward health reform. Key findings are outlined in a report, *Views of Missouri Voters on Issues Relating to Health Care Reform*. The survey found that more than half of the respondents claim not to support the health care law; however, they indicate support of some of the law's provisions. Sixty percent of those surveyed view the affordability of health insurance as a significant issue. Further, 68 percent of respondents indicated that they were "strongly in favor" of provisions in the law for people to keep their current insurance. In addition, 62 percent reported that they strongly favored health insurance tax credits for small businesses. With regard to reform, 48 percent of respondents said they were more concerned about changing the current system too much; 29 percent said they were more concerned about keeping it as it is.
