NEW GRANTS & PROGRAMS

- **Blue Cross and Blue Shield of North Carolina Foundation** (Chapel Hill) awarded a three-year, \$610,000 grant to the **North Carolina Dental Health Fund** of the **North Carolina Dental Society** (Cary). Funding will help provide uninsured and low-income North Carolinians access to quality dental care by supporting a new dental X-ray bus that will travel across the state and offer dental care to more than 6,000 individuals each year. The dental X-ray bus will support **Missions of Mercy** free dental clinics throughout the state by providing X-rays for uninsured or low-income patients. The vehicle houses four digital X-ray machines and helps dentists provide more efficient and effective diagnosis and a higher quality of care. The dental X-ray bus will be staffed by volunteer dental professionals and community volunteers. These two-day mass clinics are expected to provide more than \$1.8 million in care this year. - **Blue Shield of California Foundation** (San Francisco) awarded nearly \$9 million in grants with a primary focus on helping California meet immediate health needs. Among the grantees are: **Youth Radio** (Oakland, CA) – \$425,000 to expand the reach of the BOM (“Boss of Me”) social marketing campaign designed to prevent teen dating violence; **California Partnership to End Domestic Violence** (Sacramento) – \$345,000 to help the partnership unify and strengthen the

domestic violence field in California and help the organization be an effective advocate for essential, continued public funding for the organizations that serve families impacted by domestic violence; and **San Diegans for Healthcare Coverage** (CA) – \$100,000 to develop the **San Diego Roadmap to Health Coverage and Care**, which will assess the local need for better access to care, identify options for expanding coverage, and develop a plan to strengthen local safety net providers. - **CareFirst BlueCross BlueShield** (CareFirst) (Owings Mills, MD) made a \$100,000 contribution to **Health Care for the Homeless** (HCH) (Baltimore, MD), which works to reduce the incidence and burdens of homelessness through health-related services, education, and advocacy. HCH provides a comprehensive range of medical care, mental health services, social services, addiction treatment, outreach, dental care, prison reentry services, housing, and access to employment for thousands of Marylanders annually at clinic sites throughout central Maryland. Seventy-five percent of HCH clients are uninsured. The funding is part of CareFirst’s **Community Touchdowns** program, which contributes \$1,000 for every touchdown scored by the Baltimore Ravens during a home game throughout the 2009-2010 football season. This year’s contribution of \$100,000, representing additional support from CareFirst, will help establish the CareFirst BlueCross BlueShield Pediatric Clinic at HCH. - **The Colorado Health Foundation** (Denver) awarded nearly \$18 million to Colorado's 15 Federally Qualified Health Centers to cover expenses ranging from construction projects, to simple operating costs. Among the grantees are: **Metro Community Provider Network** (Englewood) – \$3 million to help the clinic acquire land for a new facility that will provide a full range of services, including primary, behavioral, and oral health care along with other community and social support services; **Sunrise Community Health Center** (Greeley) – \$1.2 million to support the addition of two primary care teams, as well as the expansion of a dental clinic, and to purchase necessary medical and dental equipment; **Colorado Coalition for the Homeless** (Denver) – \$700,000, which will allow the coalition to continue to employ a medical/mental health team and maintain services to serve approximately 4,200 patients this year. National AIDS Fund (NAF)

(Washington, DC), with support from the **Ford Foundation** (New York, NY), awarded nearly \$1.3 million in grants to 21 community-based HIV/AIDS organizations in nine southern states to promote public policies that address the needs of vulnerable populations. Funding will support the development of programs that seek to achieve social change; shape responsible HIV/AIDS public policy; and/or respond to the underlying legal, political, and systemic barriers contributing to disproportionate rates of HIV/AIDS in the southern United States. The 2010-11 grant awards integrate two NAF grantmaking initiatives that have focused on HIV/AIDS in the nation's southern region – **Southern REACH** and **Gulf Coast HIV/AIDS Relief Fund**. Funding was awarded to organizations in Alabama, Arkansas, Florida, Georgia, Louisiana, Mississippi, North Carolina, South Carolina, and Tennessee. For more information, visit www.aidsfund.org. - **Regence Foundation** (Portland,

OR) awarded a \$20,000 grant to **Humphreys Diabetes Center** (Boise, IA). The grant is part of the foundation's **Transformation Grant**, which selects grantees from organizations that are nominated by foundation employees. Humphreys Diabetes Center provides education in diabetes self-management and prevention to people with or at-risk for diabetes, their families, and health care professionals. The center has five outpatient facilities and four inpatient facilities. It provides diabetes services and education to more than 4,500 patients each year and more than 550 health care providers. Funding from the foundation will be used to install a new communications system that links the center's five diabetes education sites across the region and their diabetes educators working in four area hospitals. ■ **Rose Community Foundation**

(Denver, CO) awarded 60 grants totaling more than \$1.1 million. Among the grantees are: **The Center for African American Health** (Denver) – \$80,000 to support work toward improving the health and well-being of the African-American community; **Planned Parenthood of the Rocky Mountains** (Denver) – \$45,000 for education programs aimed at reducing unintended teen pregnancy and the incidence of sexually transmitted diseases; **Sisters of Color United for Education** (Denver) – \$45,000 to support a community-based health education and outreach program for the Latino community; **Catholic Charities** (Denver) – \$25,000 to support programs for low-income older adults and their families; and **Second Wind Fund of Metro Denver** (Lakewood) – \$25,000 to support counseling services for low-income, uninsured, or underinsured suicidal teens. ■ **Saint Luke's Foundation of**

Cleveland, Ohio awarded more than \$1.4 million in grants to support local safety net and basic needs organizations. **The Free Clinic of Greater Cleveland** received \$150,000 for its work serving a population comprised of 93 percent of patients with no health insurance. A

\$75,000 grant went to **North Coast Health Ministry**, the only free clinic in Ohio with electronic medical records and the only drug repository in Cuyahoga County. Also, a \$50,000 grant for strategic planning was awarded to **ADAMHS Board**, a new merger between the Alcohol and Drug Addiction Services Board and the Mental Health Board. The **Legal Aid Society of Cleveland** received \$75,000 for its Community Advocacy Program, a collaboration with MetroHealth aimed at eliminating legal barriers to maintaining health and accessing health care. Among the grantees are: **Infant Welfare Society of Chicago** – \$60,000 toward the salary of the lead nurse in a clinic for women in need of preventive and chronic disease management services; **Health and Medicine Policy Research Group** – \$46,000 for the **Chicago Area Schweitzer Fellows Program** to fund six nursing fellows to provide direct service in medically underserved areas of Chicago; **Family**

Methodist Healthcare Ministries of South Texas, Inc. (MHM) was formed in 1995 to honor the responsibility that began in 1955 when the Southwest Conference of The United Methodist Church chartered the Southwest Texas Methodist Hospital. MHM was organized as a public charity to fulfill two major roles. First, it would serve as the locally based 50-percent owner of the Methodist Healthcare System and maintain local governance of the community's most respected health care provider. Second, it would be charged with carrying out a healing ministry to underserved individuals in San Antonio and South Texas.

Program Information: MHM's mission is "Serving Humanity to Honor God" by improving the physical, mental, and spiritual health of those least served in the Southwest Texas Conference area of The United Methodist Church. The organization's funding and initiatives target low-income families and uninsured individuals in South Texas. MHM has identified the following areas as priorities and provides support to partners who address these issues: access to care, children and youth mental health, diabetes and obesity prevention, and health care professional shortage.

► Financial Information:

Total Assets: \$515 million (FY 2009)

Amount Dedicated to Health-Related Grants: \$35.7 million (FY 2009)

► Special Initiatives and Representative Health Grants in 2010:

- **Access to Care** – Texas has the highest rate of uninsured in the nation, and MHM has devoted substantial support (\$22 million this year) through its own programs and grants to make health care accessible to those least served. Last year, MHM gave \$7.1 million to Haven for Hope – a public-private venture providing transformational services for the homeless in San Antonio – to build health care facilities, and MHM continues to support the medical, dental, and vision care providers offering services in those facilities. In 2009 MHM also invested \$12 million to build its own Wesley Health & Wellness Center.
- **Diabetes and Obesity Prevention** – Nearly two-thirds of Texas adults are overweight or obese, and 2.25 million have

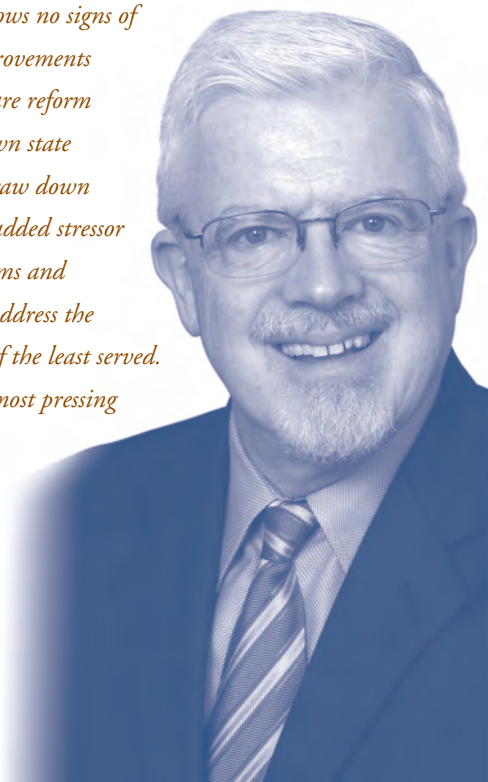
some form of diabetes. MHM operates its own prevention programs and will provide over \$1 million in funds to support diabetes and obesity prevention initiatives in 2010.

- **Health Care Professional Shortage** – By 2020 Texas is projected to be 71,000 full-time employees short of the nurses it will need. MHM has partnered with local academic institutions to increase enrollment and faculty in nursing programs. Over \$3 million in 2010 will be awarded to this initiative, including a general surgery residency program.
- **Children and Youth Mental Health** – There are 1.2 million children in Texas with a diagnosable form of mental illness. Only about 25 percent of those children receive public services; Texas is 49th in the nation on mental health spending per capita. In 2010 MHM will award \$1.5 million in mental and behavioral health grants, half of which are devoted to youth.

Most Pressing Health and Human Services Issues:

"There are approximately 32 million uninsured in the United States and 6 million of those people live in Texas. The need for health care services in South Texas in particular has grown at an alarming rate and shows no signs of slowing, even with the improvements the recently passed health care reform legislation promises. Our own state legislature's reluctance to draw down federal funds has posed an added stressor to support the many programs and services that are needed to address the primary health care needs of the least served. From that perspective, the most pressing health and human services issue we face is the lack of state funding and political will to fund services."

SURVEYS, STUDIES & PUBLICATIONS

■ **Mary Black Foundation**

(Spartanburg, SC) released a report that addresses the concept of walkable communities for Spartanburg County, South Carolina. ***Bright Future: Working to Ensure a Healthy Community*** emphasizes the importance of active living to health and outlines how walkable communities can contribute to a more active lifestyle. The report notes that although access to walking trails has increased over the past four years, the number of residents who have used walking as transportation has decreased during that time. The report also gives an assessment of Spartanburg’s walkability and provides recommendations to make the community more walker friendly, asserting that investments in infrastructure, education, and awareness will help create a culture of walkability and thus produce a healthier and more prosperous community. ■ **California HealthCare Foundation**

(Oakland) has published ***Health Care Costs 101***, which provides general background information on the nation’s health expenditures. The report states that in 2008, national health care spending grew 4.4 percent from 2007, representing the slowest pace in nearly 50 years. This modest increase extended

a slowing trend that has been underway since 2003. Despite the slow increase, 2008’s modest growth in health spending still outpaced the economy, and health care’s share of gross domestic product rose to 16.2 percent. Total health care spending in 2008 reached \$2.3 trillion, or \$7,681 per person. Spending for health care is shared broadly throughout the economy, constituting some 6 percent of personal income, 8 percent of total compensation paid by private business, 36 percent of federal government revenues, and 24 percent of state and local government revenues. The 2010 edition of this report is based on 2008 national data from the U.S. Department of Health and Human Services, Centers for Medicare and Medicaid Services’ Office of the Actuary. ***Health Care Costs 101*** is published as part of the **California HealthCare Foundation’s *California Health Care Almanac*** and is available at www.chcf.org.

- **DentaQuest Foundation** (St. Louis, MO) introduced the ***Electronic Compendium of Resources for Building Oral Health Coalitions***, a digital document of resources to serve professionals building community-based coalitions dedicated to oral health. The foundation developed the document in response to the U.S. Surgeon General’s ***National Call to Action to Promote Oral Health***, issued in 2003, three years after the landmark report ***Oral Health in America***, which described oral disease as a “silent epidemic” afflicting the most vulnerable people in our nation. The citations in the DentaQuest Foundation’s encyclopedic ***Electronic Compendium*** link to free, full-text publications spanning the fields of communications, management practice, oral health, prevention, psychology, public health education, and public policy. Prominent among these resources are virtual public libraries covering all aspects of community-based coalition development. Institute of Medicine (IOM) (Washington, DC) has released ***Bridging the Evidence Gap in Obesity***

Prevention: A Framework to Inform Decision Making, which outlines the results of a Kaiser Permanente-commissioned initiative to develop a framework to guide the use of evidence in decisionmaking about obesity prevention policies and programs and to guide the generation of new and relevant evidence. IOM convened a committee that, through research, developed the L.E.A.D. framework process (short for Locate evidence, Evaluate it, Assemble it, and inform Decisions). Authors of the report advocate developing a public-private partnership involving funders, publishers of research, decisionmakers, and other stakeholders to discuss the practical uses of the L.E.A.D. framework and to develop plans and a timeline for focused experimentation and potential refinement. In addition, the report calls on foundations, government, and research institutions to build a resource base and establish standards for quality evidence. - **Milbank Memorial Fund** (New York, NY) has published the new report ***Evolving Models of Behavioral Health Integration in Primary Care***, which offers an approach to meeting the unmet needs of the millions of Americans suffering from mental illness and substance abuse: the integration of primary care and behavioral health care. The report summarizes available evidence and states’ experiences around integration as a means for delivering quality, effective physical and mental health care. For those interested in integrating care, it provides eight models that represent qualitatively different ways of integrating and coordinating care across a continuum – from minimal collaboration, to partial integration, to full integration – according to stakeholder needs, resources, and practice patterns. ■ **RCHN Community Health Foundation** (New York, NY)

released *Medical-Legal Partnerships: Addressing the Unmet Legal Needs of Health Center Patients*. This report, which outlines the results of a study by Geiger Gibson/RCHN Community Health Foundation Research Collaborative at The George Washington University School of Public Health and Health Services, examines the role of medical-legal partnerships (MLPs) as catalysts for improving the overall health of low-income and vulnerable patients by addressing their legal needs. According to the document, 50 to 85 percent of health center patients – or between 10 and 17 million people – experience unmet legal needs, many of which negatively impact their health. Moreover, report authors project that this number is likely to increase given the significant changes in eligibility, plan enrollment, provider selection, and service delivery embodied in the newly enacted health reform law. Given their comprehensive approach to health care and high proportion of low-income patients, health centers could serve as an excellent entry point for low-income populations to legal services, the authors claim. - **Cardinal Health Foundation** (Dublin, OH) funded the development of **Generation Rx**, an on-line toolkit that aims to help pharmacists work with concerned citizens, local schools, and civic organizations to address the abuse of prescription medication. The toolkit was created with input from pharmacists and contains communications materials needed to educate local schools and community organizations about the scope and consequences of prescription medication abuse and misuse. It also shares information about how to safely store and dispose of prescription medications, how to learn more about this problem, and action steps to prevent it. The kit was developed by **The Ohio State University College of Pharmacy** (Columbus). After an initial pilot rollout

in Ohio, Cardinal Health and The Ohio State University College of Pharmacy plan to make these educational materials available for use nationwide. The toolkit is a key component of a broader partnership between the two entities to increase public awareness of prescription medication abuse and to encourage health care providers, community leaders, parents, teens, and college students to actively work to prevent it.
