NEW GRANTS & PROGRAMS

■ **BHHS Legacy Foundation** (Phoenix, AZ) has pledged to donate up to \$50,000 for relief efforts pursuant to this year's recent tornadoes and severe storms. In the Phoenix area, the foundation will provide a \$2 for \$1 match, up to \$30,000, for every contribution to the foundation's fundraising affiliate, the **Legacy Connection**. For donations throughout the tri-state region, which includes Bullhead City, Fort Mohave, and Topock, Arizona; Laughlin, Nevada; and Needles, California, the foundation will provide relief funding of up to \$20,000, matching \$2 for every \$1. Donations must be made by November 2011 to be eligible for the match. All funds will be distributed to the **American Red Cross, Grand Canyon Chapter** (Phoenix, AZ) to provide health and mental health services and supplies to assist victims of the 2011 spring storms. - **Kaiser Permanente** (Oakland, CA) announced the funding of 217 grants nationwide, totaling approximately \$7.7 million. Among the grantees is **La Clinica de La Raza**, an Oakland-based community clinic that provides comprehensive health care to economically challenged people in the San Francisco Bay Area. The clinic received the third installment of a \$150,000, three-year grant for a new community clinic in North Vallejo, California. Kaiser Permanente is also providing continued support for a community-supported agriculture site owned and operated by **Denver Botanic Gardens**. The garden is partly a working farm that engages community residents in the growing process and donates food to local food banks that serve the homeless. **University Hospitals of Ohio** launched the **Centering Pregnancy** program in 2010, as part of a \$90,000 grant from Kaiser Permanente, to be distributed over three years. The program treated 190 teenage mothers in its first year and expects to enroll 500 in 2011. In addition, the program enables young mothers to actively participate in their prenatal care and participate in group discussions with other mothers their age with similar due dates. - **Mat-Su Health Foundation** (Wasilla, AK) awarded more than \$1 million to six nonprofit organizations serving residents in Alaska’s Mat-Su region. A \$500,000 grant to the **Salvation Army** (Wasilla) will support its new community center at King’s Lake. This new facility will consolidate

many of the organization's social services, including a food and clothing bank, recovery services to individuals battling addictions, and relief supplies for disaster victims. **Set Free Alaska** (Palmer), which offers faith-based outpatient alcohol and drug treatment services, will receive \$200,000 over a two-year period to develop business plans and the capacity to sustain operations over the long term. **Alaska Legal Services** (Anchorage) received \$46,750 to replicate a legal assistance program that is successful in other parts of the country. Attorneys will work with local nonprofits that bill Medicaid/Medicare for health-related services to address claims denials and improve approval rates. - **Blue Cross Blue Shield of Massachusetts Foundation** (Boston) and **Robert Wood Johnson Foundation** (Princeton, NJ) have released *Implementing a Successful Public Education and Marketing Campaign to Promote State Health Insurance Exchanges*, the second installment in its Health Reform Toolkit Series. This resource highlights lessons learned from Massachusetts' efforts in managing health exchanges and offers suggestions for other states, including enlisting marketing and advertising expertise, using cost-conscious digital marketing methods, developing partnerships to broaden the reach of marketing efforts, and continually measuring and publicizing successes. - **California HealthCare Foundation** (Oakland) funded two policy briefs that examine California's newly eligible for health care coverage resulting from the expansion of Medicaid and through subsidies via health insurance exchanges as part of the Affordable Care Act: *Californians Newly Eligible for Medi-Cal Under Health Care Reform* and *Who Can Participate in the California Health Benefit Exchange?* The reports cite research estimating nearly 4.6 million state residents may become eligible for coverage. The studies, which analyzed data from the 2009 California Health Interview Survey, found that a significant percentage of those newly eligible for both the California Health Benefit Exchange and Medi-Cal expansion were single, working-age, or men between the ages of 18 and 44, although it is expected that these characteristics will change over the next three years. - **The Commonwealth Fund** (New York NY) recently released *Realizing Health Reform's Potential – Women at Risk: Why Increasing Numbers of Women Are Failing to Get the Health Care They Need and How the Affordable Care Act Will Help*. The issue brief addresses difficulties women face in securing adequate health care that covers needs that are specific to women, such as maternity care. The brief also addresses cost implications, including the trend of charging young women more than their male counterparts of the same age. The publication focuses on how the Affordable Care Act is bringing positive changes for women, including required free coverage of preventive care services; small business tax credits; new affordable coverage options; and insurance market reforms, including bans on gender rating. The report also asserts that the vast majority of working-age women who were uninsured in 2010 will be fully covered after provisions of the act are fully implemented.
