


The Problem of Health Care Spending: The RAND Corporation projects that health care spending in MA will increase from \$65 billion/year in 2010 to \$123 billion/year in 2020

"In the absence of policy change, health care spending [in MA] is projected to nearly double...




Obesity Rates by States, 1997



Spending Mismatch: Health Care vs. the Determinants of Health


Mismatch: Health Determinants vs. Health Expenditures


National Health Expenditures 2005.

State Budget FY'01 – '10: In MA – and the US – health care costs are crowding out investment in the basic determinants of health:



TBF Special Initiative: Food & Fuel (Winter Grantmaking)

Winter 2011/2012 = \$382,808 distributed to 20 organizations serving greater Boston in the areas food insecurity, fuel assistance, and shelter/housing focused on alleviating immediate need and addressing longer term systemic change including increased SNAP utilization

- Various types of philanthropy (public charity, family, corporate giving, individual)
- Focus on emergency assistance and long-term intervention related to winter needs
- Statewide impact (as of Winter 2010/2011)
- Shared information on community needs and where funds distributed by each funder
- Targeted distribution to meet need and maximize impact of funds, limit duplication of fund distribution
- Media to bring attention to community needs, drive funding to 'vetted' organizations, spotlight funders collaborating

Conclusion

- Obesity is a major problem in the US more than 1 in 6 children in the US are obese
- Low income and food insecure people are especially vulnerable due to poverty and limited access to healthy foods
- Households with limited food budgets try to stretch by purchasing cheap energy dense foods
- Policy interventions that make healthier choices easier will likely achieve the greatest benefits
