## NEW GRANTS & PROGRAMS

- **Blue Cross and Blue Shield of Minnesota Foundation** (Eagan) announced intended funding for a new program designed to engage public libraries in improving the health of residents in low-income communities and communities of color. The **Public Libraries for Health** program engages public libraries as partners working collectively with other organizations in their service area. The foundation will award grants of up to \$50,000 each to four libraries across the state for programs or projects that advance health equity. Funds may be used for an existing project or a new opportunity. The program is part of a larger health equity initiative launched in 2011, which seeks to ensure that all Minnesotans have an equal opportunity to live a healthy life regardless of income, education, race, and other socioeconomic factors that affect health. Nemours' journey began in 1936 with the formation of The Nemours Foundation under the terms of Alfred I. duPont's will. In 1940 the Alfred I. duPont Institute opened its doors. ## SURVEYS, STUDIES & PUBLICATIONS

- **California HealthCare Foundation** (Oakland) published the results of a study that measures customer satisfaction for Californians who receive health insurance through Medi-Cal, California's Medicaid program.

*Medi-Cal at a Crossroads: What Enrollees Say about the Program* reports that 9 out of 10 Medi-Cal recipients have a positive view of the program. Sixty-nine percent indicate they are satisfied with their care, and 79 percent say it is easy to locate a primary care physician nearby who accepts Medi-Cal. In addition, enrollees report positive experiences with the enrollment process, with more than three-fourths indicating that the application is easy to complete. However, enrollees with disabilities report having less favorable experiences with and perceptions of Medi-Cal. Similarly, Medi-Cal recipients in fair or poor health report more difficulty finding specialists than enrollees in good health. The publication also provides potential challenges facing the state concerning policy and implementation. The report indicates that the state and its county partners will face challenges in providing multiple pathways for people to apply for Medi-Cal. - **Child Health and Development Institute of Connecticut, Inc.** (Farmington) published *Mid-Level*

*Developmental and Behavioral Assessments: Between Screening and Evaluation*, the latest installment in its IMPACT series. The publication suggests mid-level developmental assessments as an effective solution to some of the consequences of delays that occur between a child's referral for developmental and behavioral evaluations and when the evaluation occurs. The report, which focuses primarily on Connecticut, points to a lack of resources as a cause for these delays. The resulting wasted time, unnecessary expense, and misdirection of resources compromises the ability of the system to optimize the surveillance/screening process and opportunities for timely intervention, to the detriment of children. - **The Colorado Health Foundation** (Denver) released the first installment of *Measurable Results*. Adopted by the foundation's board of directors in 2008, *Measurable Results* serves as an evaluation tool to guide the foundation's investments and help grantees evaluate their work. It is the product of an evaluation model that emphasizes clarity and simplicity – with the intention of reducing data collection burden for grantees. Along with sharing findings from five groups, the new report highlights how the foundation evaluation model operates. Over time, *Measurable Results* and other evaluation findings will provide an inventory of learning material and analysis for the foundation, the philanthropy community, and health stakeholders in Colorado and the nation. **Grantmakers for Effective Organizations** (GEO) (Washington, DC) published *Four Essentials for Evaluation*, which lists steps grantmakers can take to maximize potential of evaluation for learning and improvement that leads to better results. The guide builds on information outlined in *Evaluation in Philanthropy*, a 2009 publication that was jointly released by GEO and the **Council**

**on Foundations** and GEO's The Learning Conference in 2011. It includes important questions, guidelines, and action steps to help grantmakers apply four steps: lead, plan, organize, and share. **NIHCM Foundation** (Washington, DC) released *Health Plan Approaches to Preconception Health*. The issue brief explores how selected health plans and foundations are addressing preconception health, including the role of private health plans and funders in promoting preconception health, how they are improving access to care, and how they are reaching women of childbearing age. - **RCHN Community Health Foundation** (New York, NY) announced that the Geiger Gibson/RCHN Community Health Foundation Research Collaborative has released *An Early Assessment of the Potential Impact of Texas' "Affiliation" Regulation on Access to Care for Low-income Women*. In light of the federal appeals court's current consideration of the legality of Texas' family planning affiliation regulation, the report provides a preliminary assessment of the impact of the Texas rule on preventive care access by low-income women, specifically concerning access to cancer screening, preventive health care, and family planning services. The report finds that the affiliation rule – which would bar Planned Parenthood Federation of America (PPFA) clinics from participating in the state's Medicaid expansion family planning program because of their affiliation with an entity that performs and advocates for legal abortions – jeopardizes access to care for nearly 52,000 low-income women. Exclusion of PPFA clinics would eliminate women's access to 16 of 26 of the state's largest **Women's**

**Health Program** providers. The report also concludes that it would be virtually impossible for health centers to fill the need given cutbacks in state family planning funding and the magnitude of the demand for health center services in the state with the nation's largest proportion of uninsured residents. **U.S. Department of Health and Human Services** (Washington, DC) has released its *Lesbian, Gay, Bisexual, and Transgender (LGBT) Coordinating Committee Report*, outlining efforts to promote the health and well-being of LGBT people. Among the accomplishments listed were the implementation of the Affordable Care Act, and the creation of an LGBT youth suicide task force. The report also outlines the department's goals for the upcoming year, which include continued efforts to address discrimination, harassment, and violence; funding pilot studies for programs that focus on reducing obesity among lesbian and bisexual women; and smoking cessation efforts, particularly for high-risk populations. - **Jewish Healthcare Foundation** (JHF) (Pittsburgh, PA) announced that **The Pittsburgh Regional Health Initiative** (PRHI), an operating arm of JHF, received a \$10.4-million **Health Care Innovation Award** from the

Center for Medicare and Medicaid Innovation (CMMI) for its **Virtual Accountable Care Network Project**. The CMMI grant will enable PRHI to bring the project's resources to a total of seven regional hospitals in western Pennsylvania, enabling small primary care practices to offer their patients better integrated care, support for care transitions, and intensive chronic disease and medication management. The new centers will focus on approximately 25,000 Medicare beneficiaries with chronic obstructive pulmonary disease, congestive heart failure, and coronary artery disease. By reducing 30-day readmissions and avoidable disease-specific admissions, PRHI estimates savings over three years of approximately \$74 million, as well as the creation of an estimated 26 new jobs and the training of 450 health care workers in disease management and primary care support skills.
