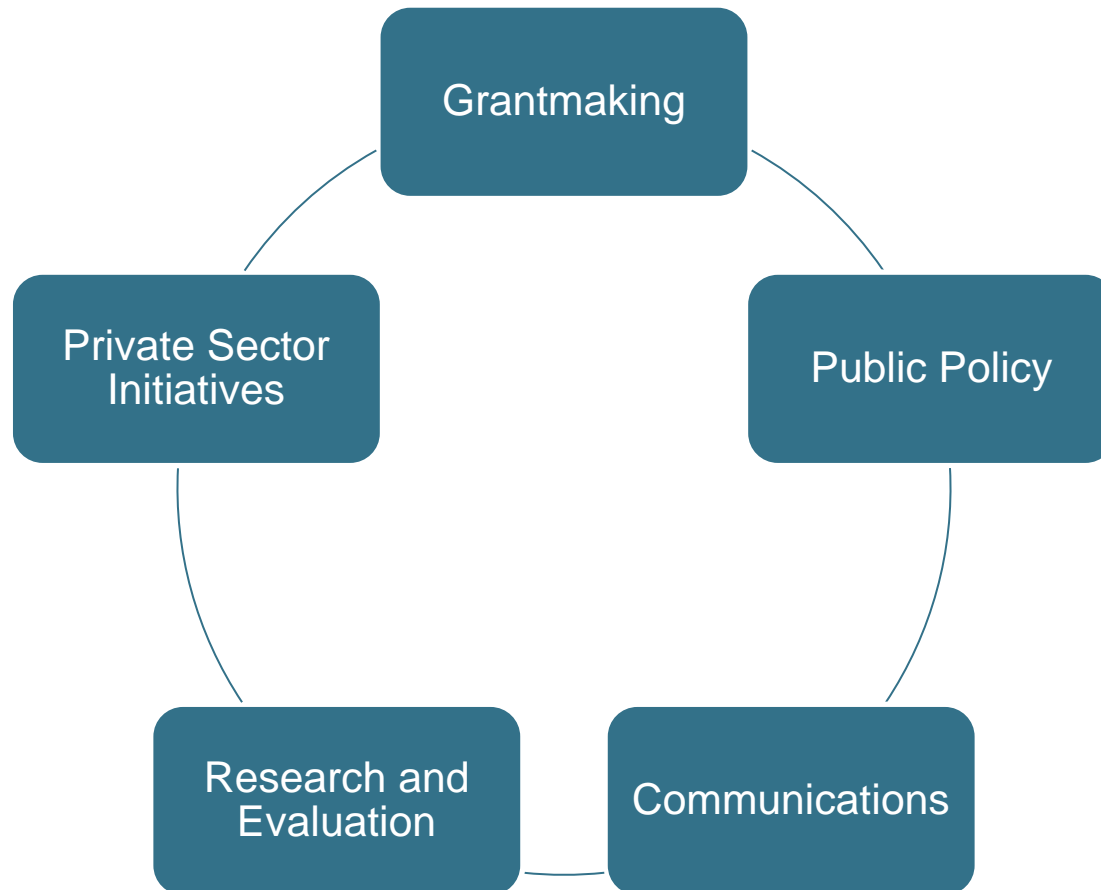


Who are we?

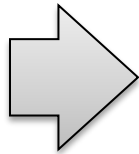

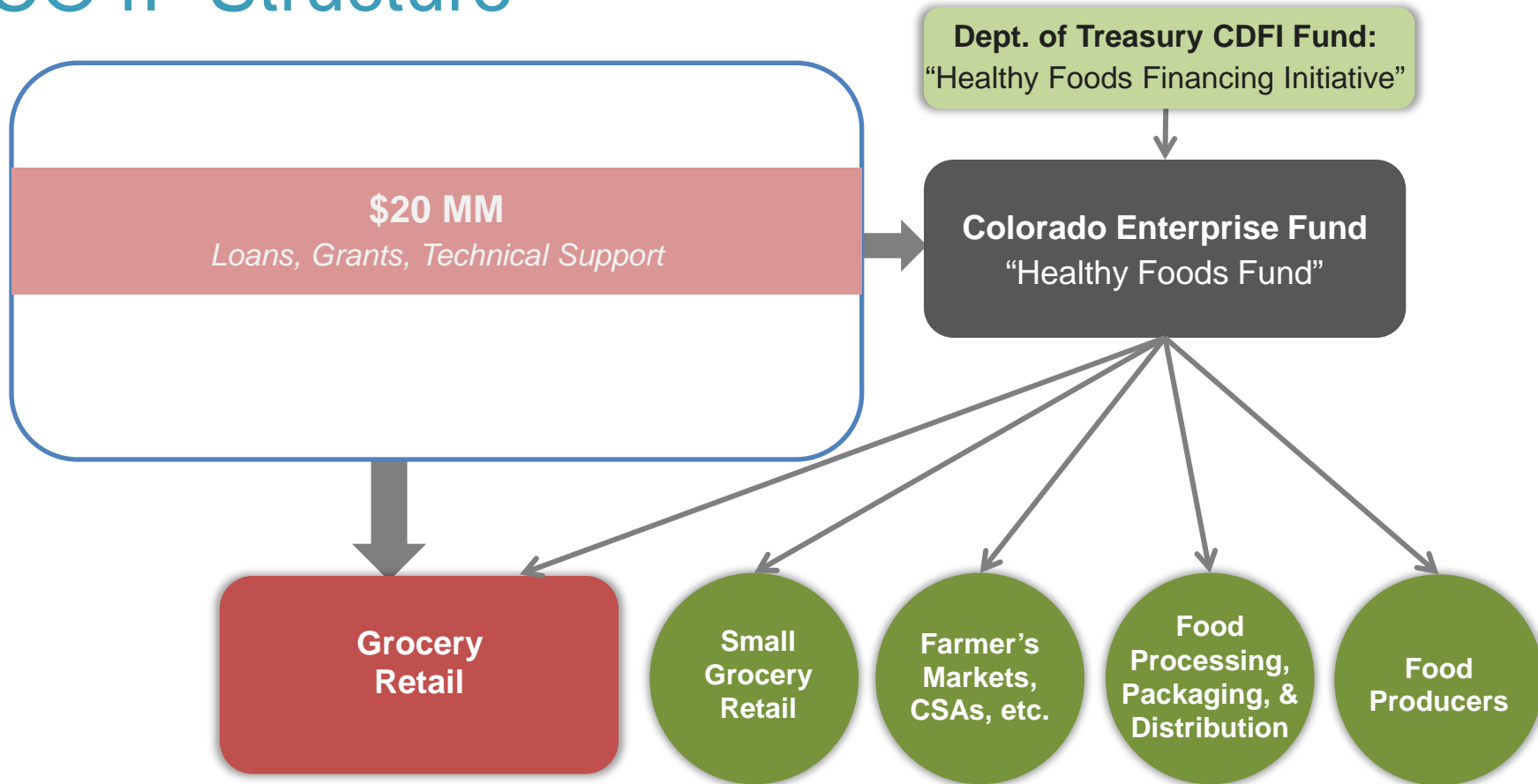

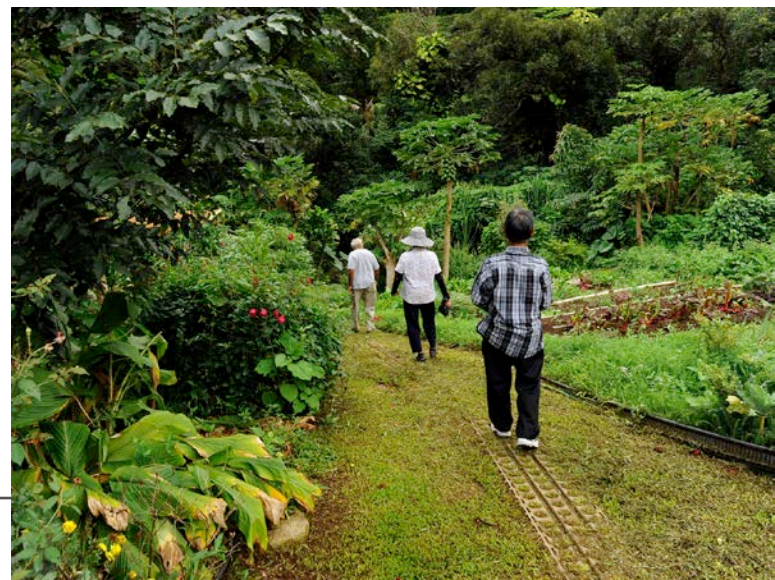


Living Cully in Portland, a cross-team grant

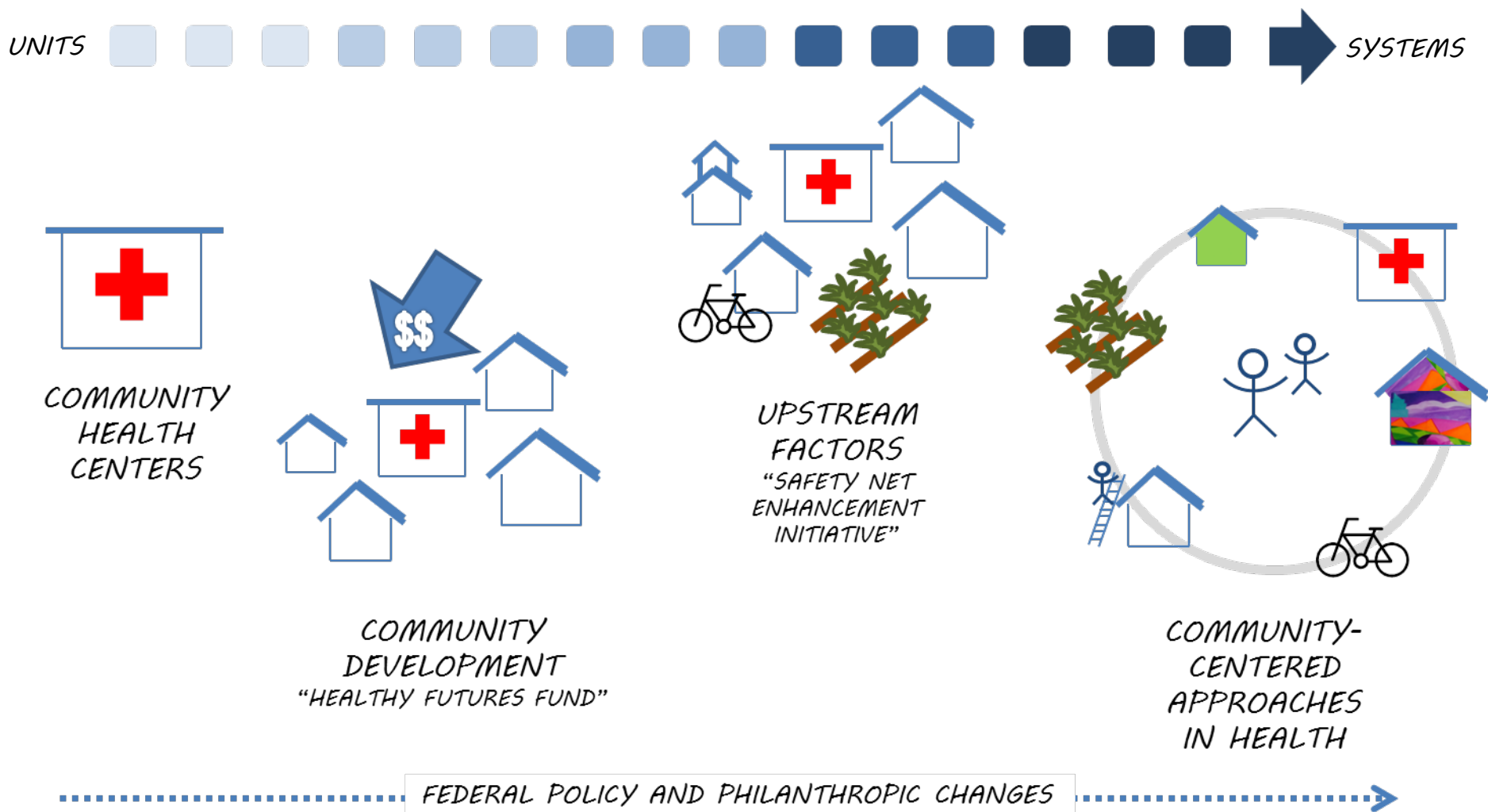

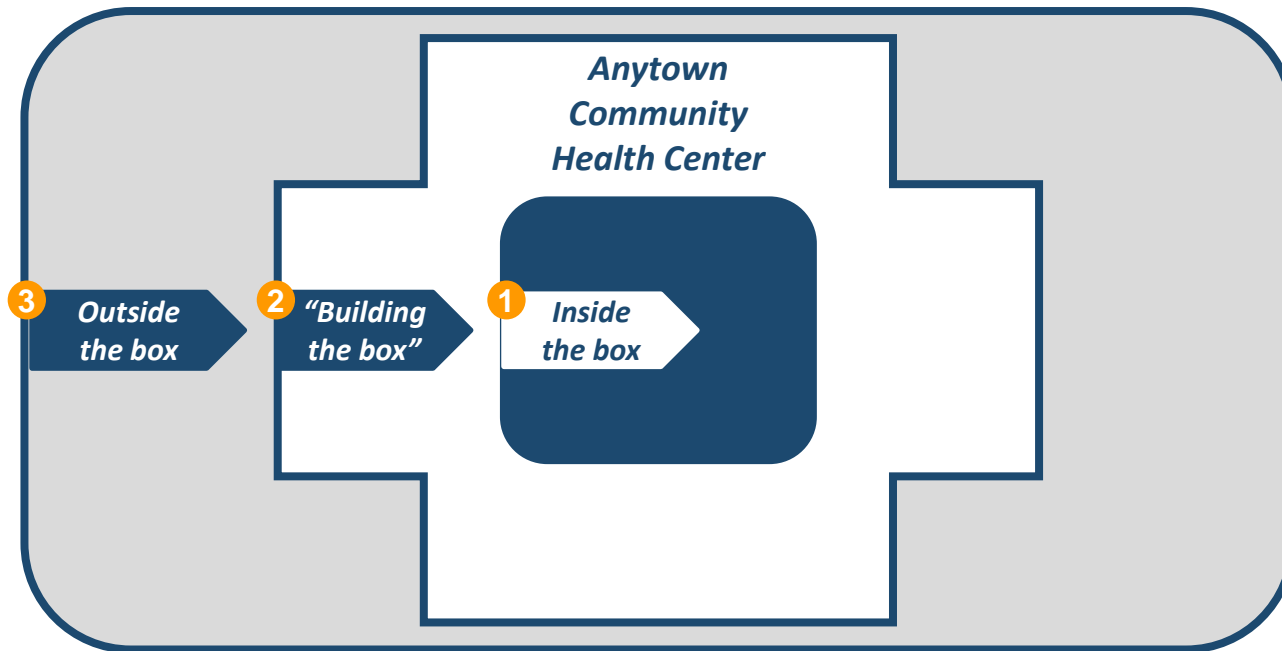


Example: Community Health Center Strategy Evolution



A draft framework to coordinate these activities...

This framework takes an individual Community Health Center as “**the box**,” within and around which various activities to promote Healthy Communities may be pursued



- 1 Inside the box** refers to daily CHC operations, including management and financial operations, data, the quality of consumer care and experience, and the breadth of services available to consumers.
- 2 "Building the box"** refers to the availability of financing for the development of new and the renovation of older health center facilities. (This includes CDFI lending and development expertise.)
- 3 Outside the box** refers to the social determinants of health, public health policy, the external products & services available to CHC consumers, and CHCs' relationships with other partners.

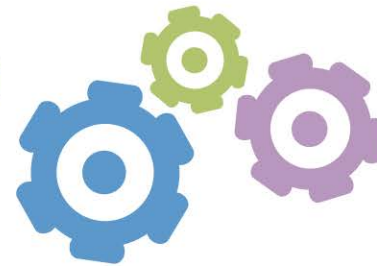

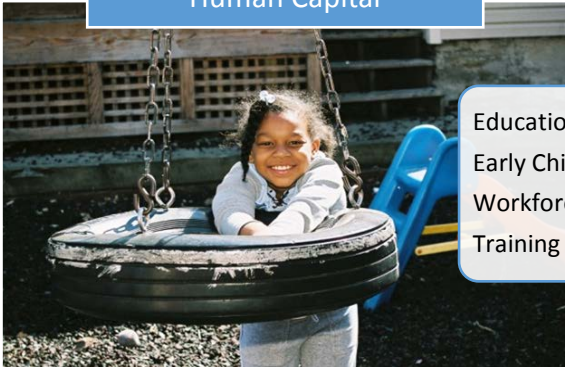

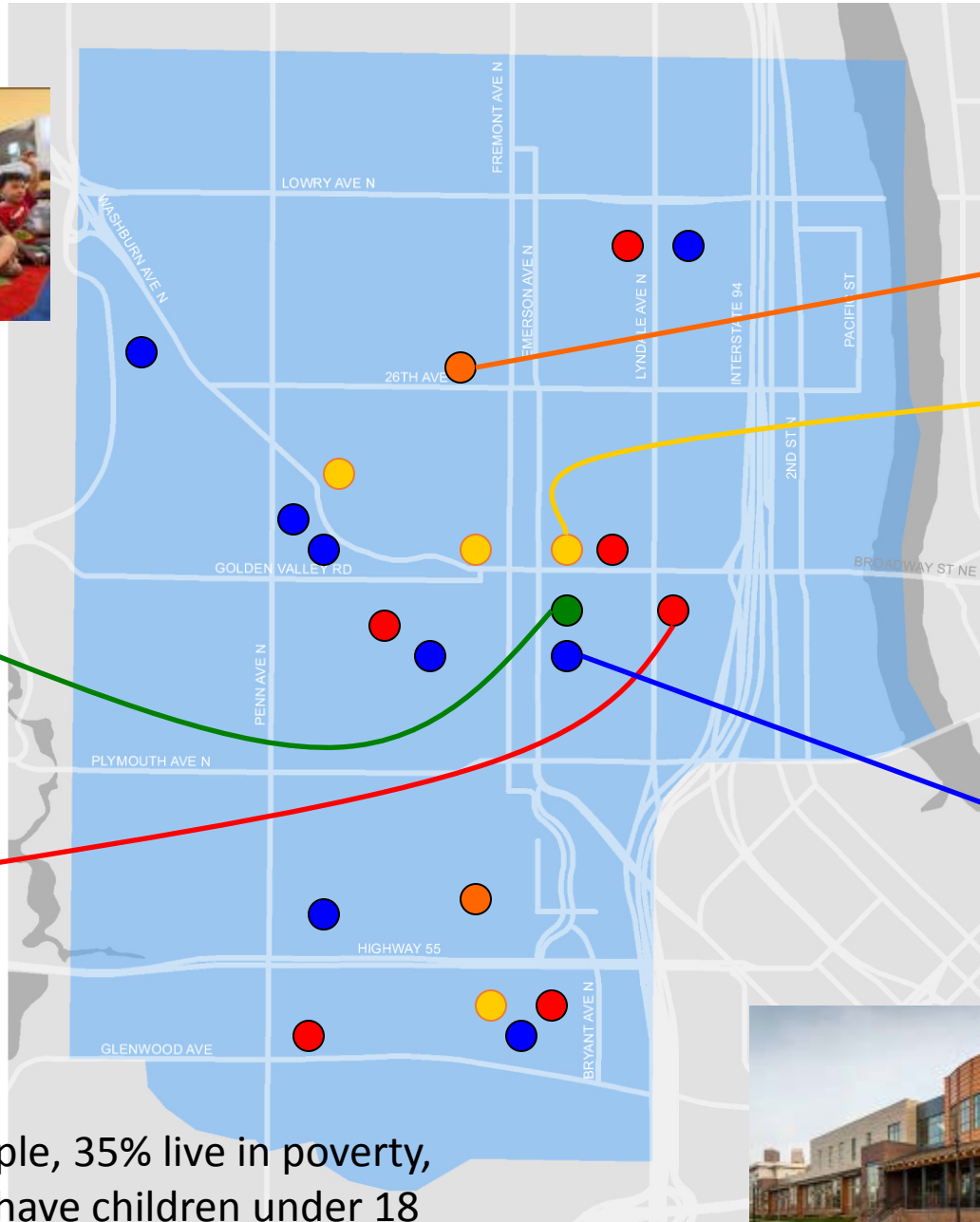

St. Paul's East Side

Rolling Hills Apartments/ East Side Family Clinic

- 108 affordable housing units with social services for immigrant population financed by LISC **Healthy Futures Fund**
 - On-site exam room serves 200 residents annually
- FQHC financed nearby with expanded services, including dental and pharmacy
- LISC *Community Health Advocate* facilitates housing/health care partnership to increase access to care, healthy eating and physical activity

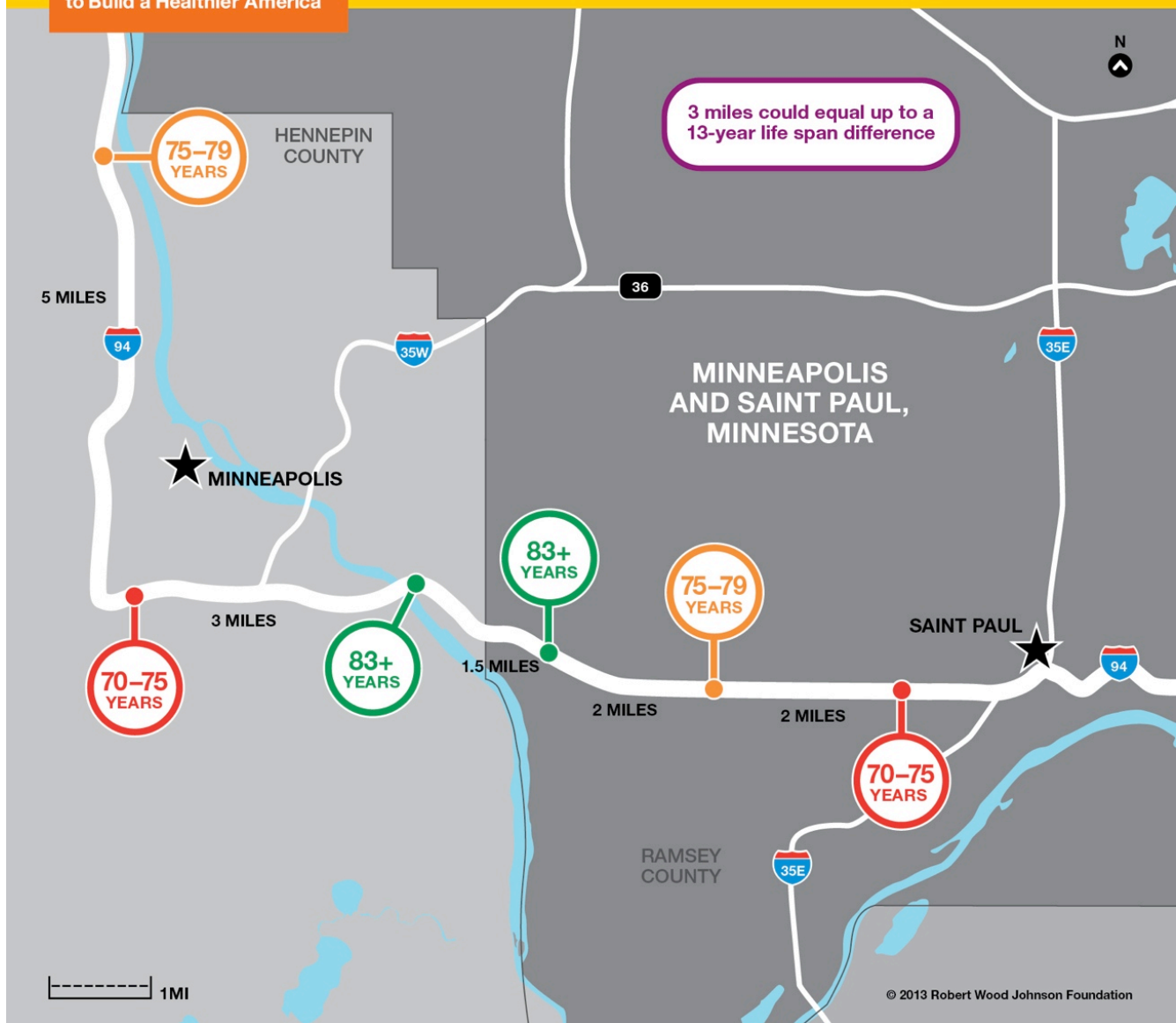

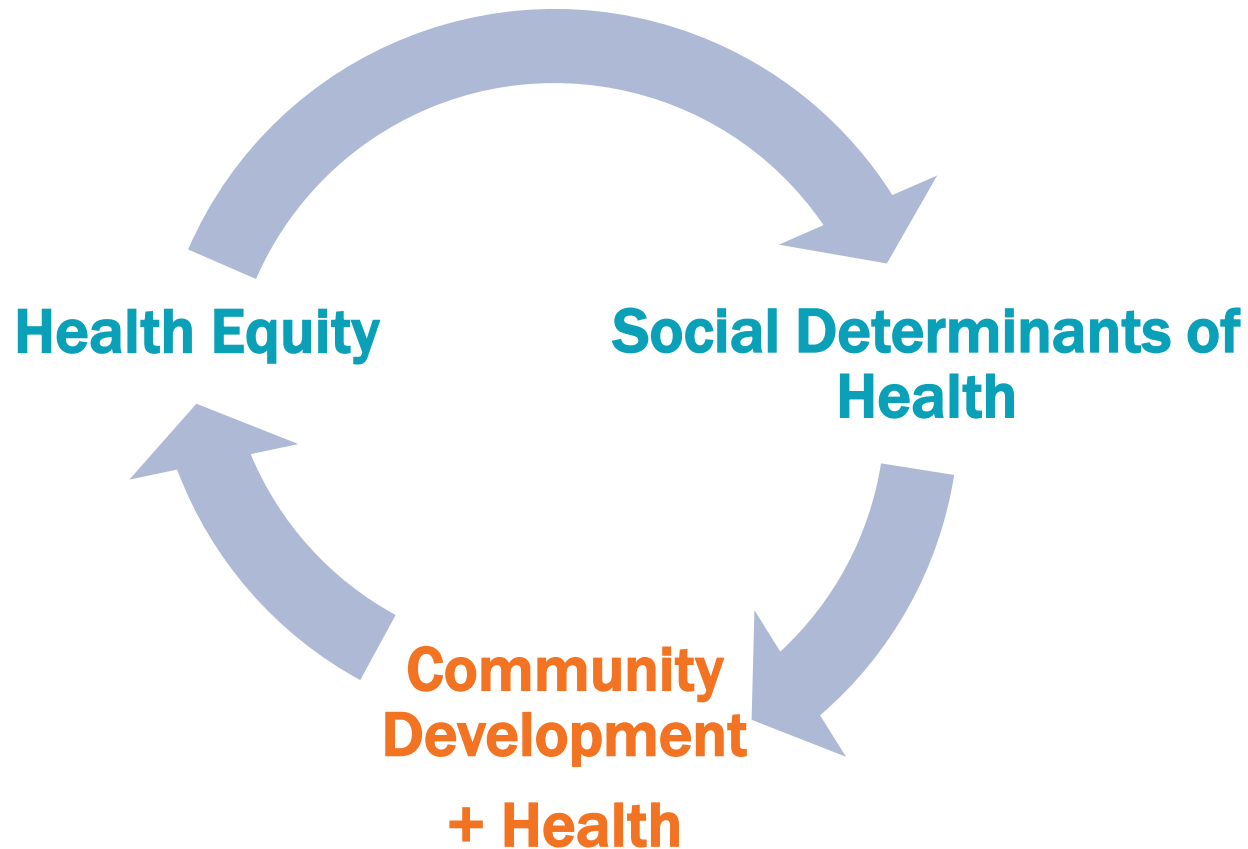
